• **NUTRITION AGREEMENT**

It is agreed that the parent will furnish a nutritious lunch. Refrigeration space is available or you may add a cold pack to your child’s lunch box. Children attending Gingerbread School will be given a nutritious morning and afternoon snack. If a parent fails to provide a nutritious and well-balanced meal it is required by the Pinellas County License Board for the school to supplement items for that child. A fee of \$2.00 will be charged to your account if it is necessary to supplement your child’s lunch. A nutritious lunch is composed of food from each of the following groups:

1. Protein (meat, cheese, eggs, chicken) We are a peanut free school. No peanuts of any kind are allowed.
2. Whole Grain Breads & Cereals (bread, crackers, dry cereal)
3. Vegetables & Fruits (fresh, raw, cooked, canned, juices)
4. Milk

We do not allow candy, fast food or carbonated beverages at Gingerbread School.
